Preamble:

The Government has established Gujarat Urban Development Mission (GUDM) as State Level Nodal Agency (SLNA) with its head quarter at Gandhinagar for the purpose of Jawaharlal Nehru National Urban Renewal Mission (JnNURM) vide Govt. Resolution dated 20th January, 2006, referred at Sr.No.(1) above. The Mission was initially established for a period of 7 years in consonance with tenure of JnNURM from the year 2005-06. However, the Government of India has extended the tenure of JnNURM upto March 2014 as referred to ^{at} (2) and (3) above, the State Government has also extended the tenure of Gujarat Urban Development Mission upto 31.3.2014 as referred to at Sr.No.(4) above.


The Governing Body Meeting of Gujarat Urban Development Mission was held on 25/9/2013 and decided to review and monitor the ongoing projects of JnNURM and other projects, implementation of Water Supply and Underground drainage under Swarnim Jayanti Mukhya Mantri Shaheri Vikas Yojana till 2017. It is Resolved by GUDM to extend the tenure of Gujarat Urban Development Mission (GUDM) upto 31.3.2017.
