Preamble:

The State Government had established Gujarat Urban Development Mission and the structure for the Mission. Accordingly Governing Body was constituted vide resolution dated 20/4/2006 mentioned above. Now that Government of India has extended the tenure of Jawaharlal Nehru Urban Renewal Mission from seven to nine years, i.e. from 2005-06 to 31<sup>st</sup> March, 2014. Further it has also decided to start the Part II of Mission. State Government has also extended the tenure of Gujarat Urban Development Mission upto 31<sup>st</sup> March, 2014. vide its resolution dated 17/1/2012 mentioned above. After carefull consideration, with a purpose to reconstitute the Governing Body government has decided to resolve as under.


